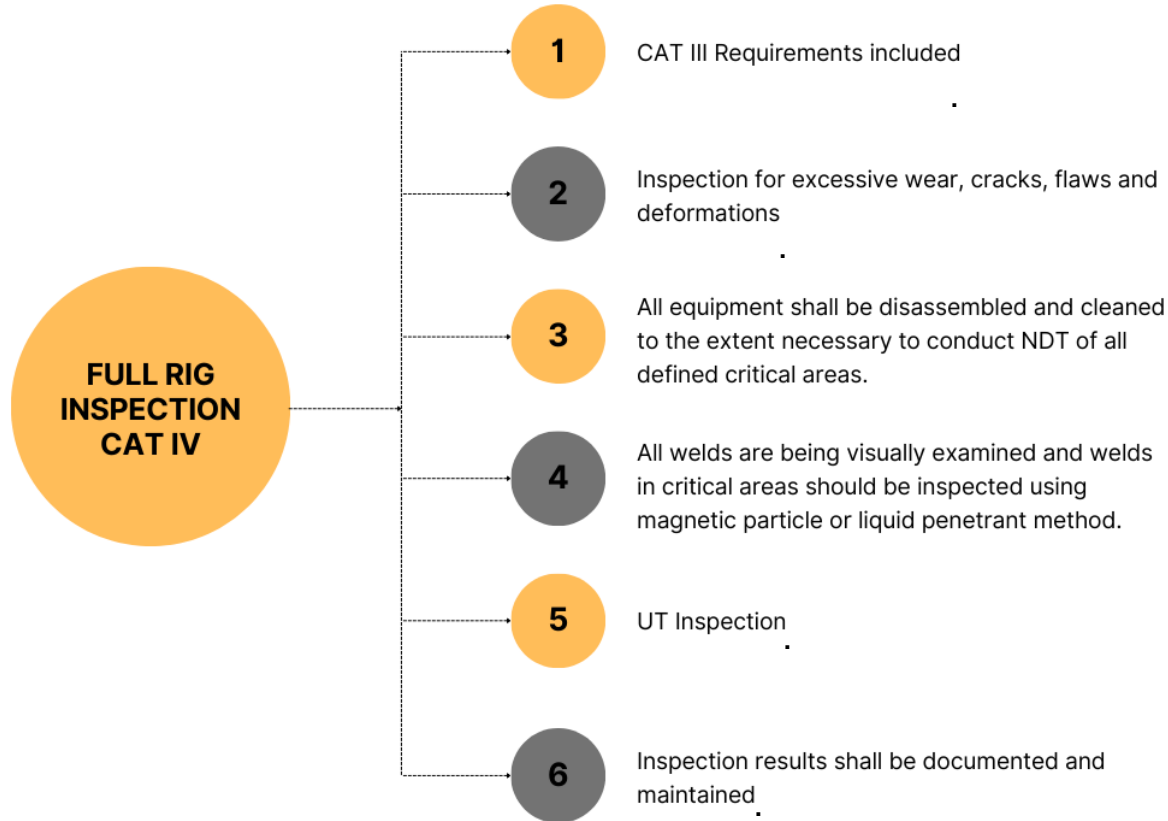
It is our objective to deliver a comprehensive reliability assessment and give an accurate insight into the state of maintenance and working condition of the rig by a detailed evaluation of equipment and systems, providing an assurance that the rig's equipment is fit for purpose.

Condition evaluations can help prevent potentially costly system failures, indicate areas where there is a need for improvement, and give a good indication on the current operability status of a rig. The areas of our assessment are also focused and pay particular attention to all Safety and Environmentally Critical Elements and all equipment that could be expected to cause operational downtime in the event of failure. Deficiencies within the maintenance system can be identified and safety critical issues will be highlighted.

API RP 4G

- Cover masts, derricks and accessories
- Cover substructures and accessories
- CAT III to be every 720 operating days
- CAT IV to be every 3650 operation days

API RP 7L

- Cover rotary tables, rotary bushings, rotary slips, rotary hoses, slush pump components, draw-works components, spiders, manual tongs, safety clamps.
- Frequency of inspection
- The owner or user of the equipment should develop his own schedule of inspections.

API RP 8G

- Basically covers all drilling and production mechanical equipment, hoisting equipment, including items also covered in API RP 4G.
- Frequency of inspection ranges from daily to every five years, and depending on the equipment as recommended on API standard. Most equipment requires a CAT III every six months.

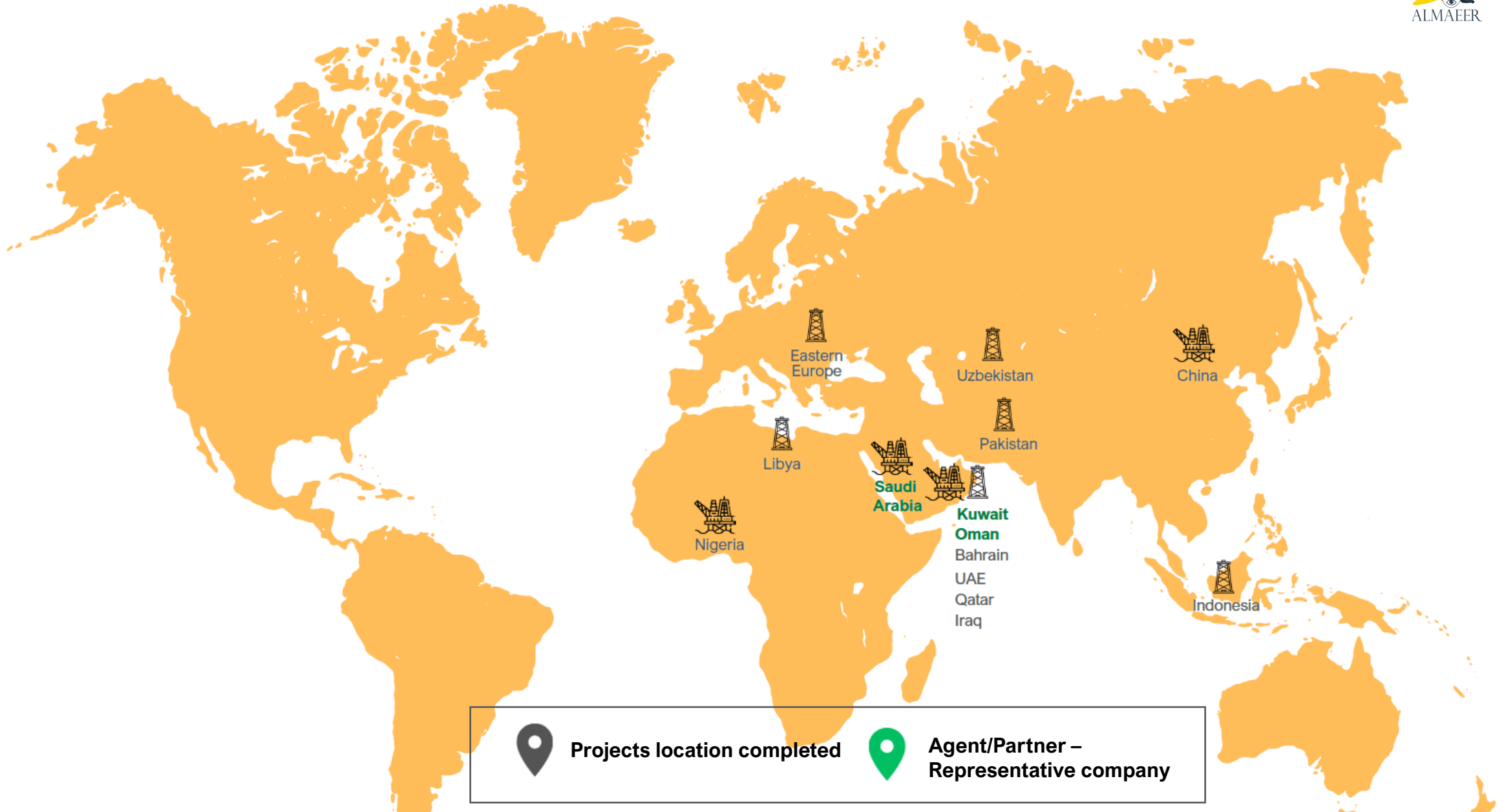

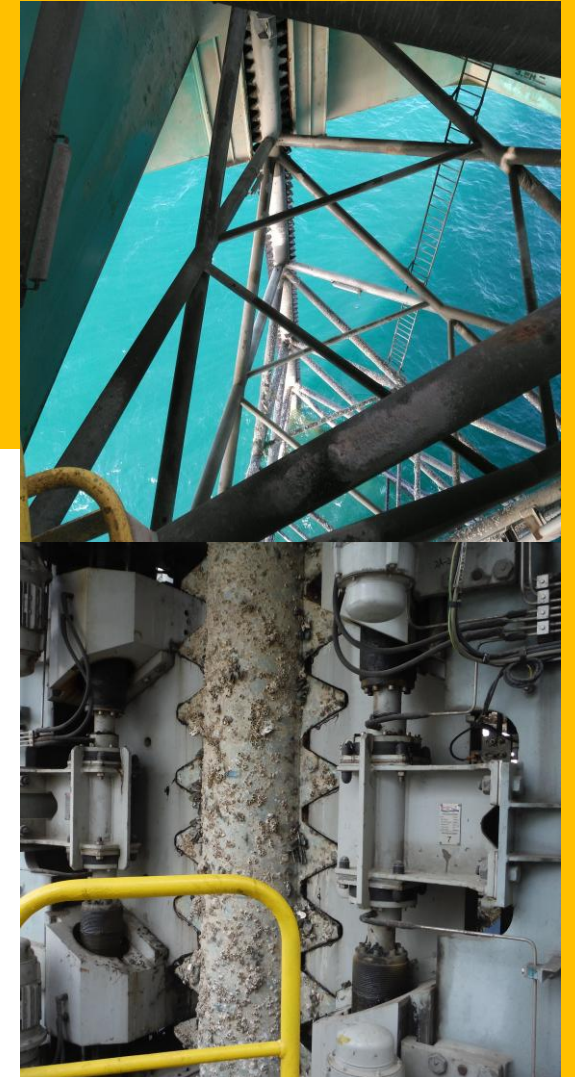


Jacking System Verification Services for more than 80 ADNOC Offshore Jack-up Rigs & Barges (3 years contract)

Jacking Systems are identified by ADNOC as a critical equipment system on offshore jack-up units. To minimize the risks of failure of the physical assets, ADNOC has directed ALMAEER to carry out independent verification of the jacking systems on all ADNOC contracted jack up rigs and jack up barges.

ALMAEER Jacking System Assurance Audits cover the following areas:

- Jacking equipment audit review to OEM and relevant standards indicating gaps where applicable.
- Monitoring of jacking trials, reviewing the functionality of the complete system operationally.
- Acceptance of all components and functionality with written documentation.
- Review recorded preventative maintenance history(s), in-house inspection reports by rig personnel, and 3rd party survey documentation for the jacking system related equipment and main generators, and indicate gaps where applicable.
- Review operational certification.
- Jacking control system audit to OEM and relevant standards.
- Where required, physically review wear on major components and carry out comparison checks with permissible tolerances using calibrated/certified Vernier and depth gauges.
- Review jacking system life rating calculations and detailed inspection intervals.
- Review competency levels.
- Spud can strength assessment.





Preventive Maintenance System (PMS) Audits for more than 140 ADNOC Drilling units, annually (6 years contract).



Under this contract, ALMAEER will carry out independent audits of ADNOC Drilling's Preventive Maintenance programmes and assess the condition of the rig equipment to all relevant standards, to ensure full compliance with industry best practices, ADNOC's internal procedures and policies, and OEM recommendations.



Audit focus areas:

- **System Reliability:** Evaluating the dependability of the OneERP PMS across all rig assets.
- **Human Reliability:** Assessing personnel adherence to maintenance work order systems.
- **Equipment Condition:** Reviewing the physical state and maintenance integrity of rig equipment.
